



# ILD-IN Annual Conference | 6–7<sup>th</sup> October 2024

## Educational Bursary Guidance Notes & Application Form

### ILD-IN educational bursary

The educational bursary covers the registration fee, one-night accommodation and access to the gala dinner to enable successful applicants to attend the ILD-IN annual conference on 6–7<sup>th</sup> October 2024. This bursary is a funded grant.

### Who can apply

Applications are invited from all healthcare professionals who are members of the ILD-IN and work within the ILD specialty.

### How to apply

You will need to complete the application form (page 2) and submit to [info@ild-in.org.uk](mailto:info@ild-in.org.uk) by **12pm on 19<sup>th</sup> July 2024**. You will receive an email confirming receipt.

### What happens next

After the deadline, all applications will be reviewed by an independent panel (bursary providers will not be involved in the selection of the recipients). Successful applicants will be notified via email by **2<sup>nd</sup> August 2024**. The panel decision is final and we will not enter into correspondence regarding their decision. If you are offered an educational bursary, you will need to accept via email by **16<sup>th</sup> August 2024**. If you fail to do this, the educational bursary will be offered to applicants on a reserve list. If you are on the reserve list and offered the educational bursary after 16<sup>th</sup> August 2024, you will have 1 week to accept before it is offered to the next person.

### Requirements of accepting the educational bursary

Once the educational bursary has been accepted by the applicant, they are committed to attending the whole ILD-IN annual conference on 6-7<sup>th</sup> October 2024. The bursary providers and its affiliates may publicly disclose (e.g. on company websites) details of its support of the bursary scheme including any relevant disclosures requested by law. Successful applicants may be sent an email from the bursary providers and asked to sign an agreement to disclose the value of the bursary. Successful applicants must either disclose the bursary as a personal transfer of value or as an aggregated figure. The bursary providers cannot sponsor anyone who refuses either of these two options. Acceptance of the educational bursary confirms consent to related information being published onto the ILD-IN website and social media channels.

In the event of exceptional unforeseen circumstances leading to a successful applicant determining that they are no longer able to attend the conference, they must contact [info@ild-in.org.uk](mailto:info@ild-in.org.uk) immediately. There will be a reserve list of applicants and under these circumstances, the next applicant on the list will be offered the bursary. If the applicant receives a bursary and fails to attend the conference and/or let us know, they may be asked to pay back the bursary.
